



Suspended and Restricted Subjects

The table below provides public information on various restrictive measures currently in force, as imposed by the Gymnastics Ethics Foundation (GEF), concerning matters within its jurisdiction.

Unless explicitly recognized by the GEF, the sanctions imposed by national bodies are not included in the table below. Additionally, the sanctions imposed by the FIG or those related to potential anti-doping rule violations are not included.

The decisions rendered by the GEF Disciplinary Authorities are not necessarily final and may be subject to appeal.

The restrictive measures include:

Provisional Suspensions

Provisional suspensions may be imposed pursuant to Part 2, Article 1.1 of the FIG Safeguarding Policy or Article 7 of the FIG Code of Discipline. It may consist of, for example, preventing a subject from coaching, judging or participating in FIG activities or events.

A provisional suspension does not constitute an early determination of guilt. Such decisions are based on a risk assessment to safeguard the interests of the sport and its participants.

Suspensions (Exclusions)

Suspensions may be imposed on individuals or National Federations (NFs) by the GEF Disciplinary Authority or the Court of Arbitration for Sport (CAS) for infringements of FIG rules under the GEF's jurisdiction.

A suspension prevents its subject from participating in or receiving accreditation for any role, including acting as coach, head of delegation or any other official position at an international competition or in any FIG-sanctioned event or competition organized by an FIG-affiliated member federation.

Probation

Probation refers to a period during which the execution of a sanction is suspended or made subject to specific conditions.
